The purpose of the Alarm Company Disciplinary Review Committee (DRC) is to review applicants' appeals of the Bureau's denials of licensure and licensees' appeals of the Bureau's suspensions and imposition of fines. Specifically, Business and Professions Code section 7591.18 states the DRC shall perform the following functions as they pertain to alarm company operators, alarm company operator qualification certificate holders, alarm company employee registrants or firearm qualification permit holders licensed, certified, or registered by the Bureau under Chapter 11.6 (commencing with Section 7590):

- (a) Affirm, rescind, or modify all appealed initial Bureau decisions which concern administrative fines assessed by the director.
- (b) Affirm, rescind, or modify all appealed initial Bureau decisions which concern denials, citations or suspensions of a license, certificate, or registration except denials, or suspensions ordered by the director in accordance with Chapter 5 (commencing with Section 11500) of Division 3 of Title 2 of the Government Code.
