The purpose of the Private Security Disciplinary Review Committee (DRC) is to review applicants' appeals of the Bureau's denials of licensure and licensees' appeals of the Bureau's suspensions and imposition of fines. The Private Security DRC is authorized to hear appeals for private patrol operators, security guards, firearm qualification permit holders, firearm training facilities and instructors, and baton training facilities and instructors licensed, certified, or registered by the Bureau under Chapter 11.5 (commencing with Section 7580), and private proprietary security officers, as registered by the Bureau under Chapter 11.4 (commencing with Section 7574).
