INSTRUCTIONS FOR COMPLETING RENEWAL APPLICATION

1. Identify the expiration date of your current license.
2. If your license has been expired for more than thirty (30) days, you must also pay the delinquency fee and check the box below.
3. Print your company name and address; check the box if changing the address.
4. Print your entire license number and sign and date the renewal application.
5. Do not send cash. Send a check or money order and fee(s) made payable to: Bureau of Security and Investigative Services and mail to P. O. Box 989002, West Sacramento, CA 95798.

PLEASE READ CAREFULLY

Each license is issued to a specific company at a specific business location. Submit your renewal application and fee(s) no earlier than ninety (90) days prior to the expiration date. A LICENSE MAY NOT BE RENEWED AFTER 3 YEARS FROM THE EXPIRATION DATE. To renew the delinquent license the renewal fees and delinquency fees must be paid from the time the license expired to present. If there has been a change of ownership, corporate officer, or manager, you must contact the bureau immediately. A change of address to a post office box or a mailbox service is allowed only if there is no mail delivery to the physical location or if the business is located in the licensee's residence. If the address has changed to a post office box or a mail box service, you must identify it as such and provide the physical location below.

YOU MAY NOT ENGAGE IN THE BUSINESS OF A PRIVATE PATROL OPERATOR AFTER THE EXPIRATION DATE UNLESS THE LICENSE IS RENEWED OR THE RENEWAL IS PENDING.

Please note, effective January 1, 1998, all licenses and registrations associated with a firearm permit must be synchronized with the same expiration date as the firearm permit. The license expiration date may reflect more than or less than the two year period. In this event, the renewal fee will be pro-rated.
