Employee Registrations

- Initial Applications
 - BreEZe: Current fee if completed and submitted before July 1, 2018 (Except Repo Agent)
 - BreEZe: New fee if completed and submitted on or after July 1, 2018 (Except Repo Agent)
 - Paper: Current fee if postmarked before July 1, 2018
 - Paper: New fee if postmarked on or after July 1, 2018
- Renewal Applications
 - Current fee if expiration date is June 30, 2018 or before
 - New fee if expiration date is July 31, 2018 or after¹

Firearm Permits (Paper Only)

- Initial Applications
 - Current fee if postmarked before July 1, 2018
 - New fee if postmarked on or after July 1, 2018
- Renewal Applications
 - Current fee if expiration date is June 30, 2018 or before
 - New fee if expiration date is July 31, 2018 or after

All BSIS Company Licenses (except Private Investigator applications)

Training Instructor Facility Certificates

Alarm Qualified Manager & Repossession Qualified Manager Certificates

All Branch Registrations

- Initial Applications (see note below)
 - BreEZe: Current application fee if completed and submitted before July 1, 2018
 - BreEZe: New application fee if completed and submitted on or after July 1, 2018
 - Paper: Current application fee if postmarked before July 1, 2018
 - Paper: New application fee if postmarked on or after July 1, 2018
- Renewal Applications (see note below)
 - Current application fee if expiration date is June 30, 2018 or before
 - New application fee if expiration date is July 31, 2018 or after

1) **NOTE:** Renewal application fees are governed by the expiration date of the license. Consequently, if a license expires July 31, 2018 or after, the new fee amount is required even if the renewal fee is paid before July 1, 2018.

Baton Permit (Baton Training Facility Requests)

- Current fee if request is made in person or postmarked before July 1, 2018
- New fee if request is made in person or postmarked on or after July 1, 2018
